EROSION ISSUES RESOLVED FOR LANDOWNER IN COVERED BRIDGE FARMS NEAR NEWARK



This eroding drainage channel was first re-graded before installing rock drop structures with plunge pools to control the erosive nature of the water during storm events. A collapsing timber retaining wall was replaced with a concrete wall and a variety of trees and shrubs planted to complete the project.

FUNDING CONTINUED FOR COVER CROP PROGRAM BY LEGISLATURE Conservation Cost-Share funding provided in the state budget by the legislature helped 54 agricultural producers plant 13,000 acres of cover crop this fall. Funding was provided by DNREC with additional funding through USDA NRCS, the Delaware Department of Agriculture and the Chesapeake Bay Program.

URBAN WATER MANAGEMENT PROJECTS PROVIDE DRAINAGE RELIEF TO HOMEOWNERS



Falling rock from a steep slope off of Riddle Avenue in Wilmington was a concern to homeowners. A green mesh and fencing was anchored into the slope covering it from top to bottom to prevent any loose rocks from tumbling to the street below.



A drainage out fall pipe from Duncan road caused severe erosion of the downstream ditch. It was re-graded and protected with riprap.

A deteriorating concrete swale and outlet erosion was in Windybush was replaced with a new concrete swale and the outlet protected with riprap.



Two homeowners in Ramblewood were affected by backyard drainage, erosion, and a decrepit timber retaining wall. The wall was removed and replaced with a new stone wall and the area re-graded and stabilized with straw matting.
